PH FY26 Fiscal and Service Reports Cooklin presented reports; *Motion to approve by Gilley; seconded by VanBeek; all ayes; motion carried.* 

PH Staffing: Sara Miller has resigned, and her last day will be August 7. At this time, she will not be replaced- Sara Skinner with HOPES in Carroll County will be covering as Supervisor for Greene County.

ECI provides funding for the HOPES Program, and with HHS moving to align service areas with Mental Health service areas. HOPES funding may be affected for FY 27. Meetings will take place in September. Cooklin and Duhrkopf have explored options for services to be provided by Lutheran Services of Iowa. We currently staff two FSWs who will stay with PH until June 2026. Possibly, they will be staffed by LSI and be housed in the current HOPES area, or they may not have space in Greene County. Cindy asked BOH to please advocate for keeping services in Greene County; it would be a great loss to our community to lose this great program.

## **Emergency Preparedness/Response Update:**

Cooklin reported that PH will receive less funding for FY26, continuing to implement Stop the Bleed in the community. Will start to focus on MRC volunteer group training for FY26.

# **Contractor Reports:**

Chuck Wenthold, Greene County Environmental Health, provided information on Environmental Health in Greene County and shared information about the Grants to Counties work plan.
